

RESOLUTION NO. 03282022-1

RESOLUTION OF THE BOARD OF DIRECTORS OF THE RIM OF THE WORLD RECREATION AND PARK DISTRICT ADJUSTING AND CONFIRMING THE BOUNDARIES FOR BY DISTRICTING VOTING FOR DIRECTORS

WHEREAS, Elections Code Sections 22000 and 22001 and Public Resources Code Section 5781 provide that the boundaries of the Rim of the World Recreation and Park District's (District) director divisions shall be reviewed and updated as necessary every 10 years and adjusted by November 1 of the year following the year in which each decennial census is taken; and

WHEREAS the most recent decennial census was taken in the year 2020 with the results available approximately a year later; and

WHEREAS the District Board of Directors retained a consultant to review those boundaries based upon the criteria set out in the law and to determine what, if any, adjustments are required; and

WHEREAS, on January 24, 2022, the District Board of Directors held a noticed public hearing on the updated map choices which more accurately reflect the demographics of the District and which slightly revise the boundaries of Divisions 4 and 5; and

WHEREAS, thereafter at its meeting of February 28, 2022 meeting, the District Board of Directors held a second noticed public hearing at which the Board of Directors reviewed the updated information and report and determined that based upon legal requirements and, considering that districts shall be relatively equal as well as issues of (a) topography, (b) geography, (c) cohesiveness, contiguity, integrity, and compactness of territory, and (d) community of interests, several adjustments to the boundaries of Divisions 4 and 5 are desirable; and

WHEREAS, on March 28, 2022, the Board of Directors held an additional noticed public hearing at which they against reviewed the updated information, report and map and determined to adopt the map attached and incorporated as Exhibit "A" as the by-district voting map for the District commencing with the November 2022 election and thereafter until again adjusted as required by law.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Desert Recreation District as follows:

1. The Recitals set forth above are true and correct.

2.	The boundaries of the District's five directorial divisions shall be as set forth in the map attached Exhibit "A.
3.	This resolution shall be effective immediately upon its adoption.
4.	Staff shall provide a certified copy of this Resolution and the map to the San Bernardino County Registrar of Voters on or before April 17, 2022.
